**MINUTES OF SETTLEMENT**

The parties agree to settle this proceeding on the following terms:

1. The Centre for Addiction and Mental Health (“CAMH”) shall pay to the plaintiff the sum of \$400,000 for general damages.
2. CAMH shall pay to the plaintiff the sum of \$11,000 for pre-judgment interest on the amount stated in paragraph 1.
3. CAMH shall pay to the plaintiff the sum of \$175,000 as a contribution towards the plaintiff’s legal costs, inclusive of HST and disbursements, of this proceeding.
4. The parties will consent to a with prejudice, without costs dismissal of this action, and to a mutual full and final release in a form acceptable to counsel, acting reasonably.

5. CAMH will provide Dr. Zucker's current contact information to any person who contacts CAMH to speak to or obtain contact information for Dr. Zucker. To the extent reasonably possible, persons who have requested Dr. Zucker's contact information since December 16, 2015 will be provided with his current contact information.

6. The parties acknowledge that the fact and terms of this settlement are not confidential.


7. CAMH will both sign and issue the letter of apology attached hereto as Schedule "A".

8. These Minutes of Settlement, and the letter of apology, will be posted to the CAMH web site and remain publicly accessible there for 30 days.


